Installment Payment Agreement - Identification Requirements

All students applying for **tuition installment payment agreements** are required to submit original or colored scans of **three valid identification documents** for screening and compliance purposes. The following ID's are acceptable:

Mandatory

- 1. USP ID Card**
- 2. FRCS Joint Card (Fiji Students)**
- 3. Passport (Regional Students)**

One ID from the list below. Out of the three, one should include residential details of the student:

1. Valid Voter registration card/ National Identification Card
2. Valid Driver's License
3. Valid Passport
4. Other valid government issued identification card.

In the case that you do not have your USP ID card, you are required to provide three forms of identification from the list above.

If the student applying is not able to provide an ID with residential address, the following will be accepted:

- Utility bills displaying the residential address. Should the names differ, we will confirm details with the addressee.

We request your understanding towards the above requirements which have been implemented to strengthen the University's credit initiative towards its students and also promote a stress free environment for learning.

Installment agreement forms without the required IDs will not be processed.
